3 個考試單元 (英文理論筆試、英文路試、教授英文駕駛堂考試)

整個課程所需時間

3-4 個月

課程成本

£2,997 + 政府考試費 £303

Chris Kelly 駕駛學院提供邊學邊賺 (最後一考試單完進行時, 可以開始賺取教車師傅收費)

主要營運成本

- 汽車保險費 (平時每年普通汽車既保險費, 再加£350)
- * 每星期£125 特許經營費(每年可豁免 5 星期既特許經營費) 每年費用約 £5,875
- 額外油費約 每星期£80 (以 47 星期黎計算, 每年約£3,800)
- 每年換一條新車軚約£475
- *以 Chris Kelly 駕駛學院教車師傅為例

每年主要營運成本 共約£10,500

採購支出

- 車 £10,000 – 15,000 (根據個人選擇)
有 d 教車師傅選擇租車黎教, 每月租車費用約£250
- 安裝副駕駛煞車系統£450
- 汽車標誌及車頂顯示屏£0.00 (以 Chris Kelly 駕駛學院教車師傅為例)

以每 100 分鐘課堂收 £70 為例 (Chris Kelly 駕駛學院課堂模式)

每年 48 星期工作, 每星期 5 天工作, 每日上 4 堂

收入約£67,200

學生由 Chris Kelly 駕駛學院安排俾你。

宜家學生學車要等 3 個月輪候時間表, 教車師傅唔怕無學生教。

扣除營運成本後既收入 £56,700

扣除 NI, 稅項 & Pension 每年約£11,000

淨收入每年總約 £45,700 (以每年工作 48 星期為例)

淨收入每月總約£38,08 (以每年工作 48 星期為例)

好處 – 彈性, 可根據個人需要, 賺多 d 或賺少 d.

Stages of becoming a driving instructor

3 modules

Duration of the course from start to fully qualified

3 – 4 months

Cost of the course

£2,997 + exam fees of £303

Earn while you learn available with CK (earn full rate whilst completing final module)

Core Operating Costs

- Insurance approximately £350 per year additional to normal car insurance
 - *£125 p/w franchise fee (5 weeks fee waived each year) annual fee = £5,875
 - Additional petrol £80 p/w (£3,800 p/year on a 47 week year)
 - 1 set of extra tyres per year £475
- *When driving as a Chris Kelly Instructor*

TOTAL CORE OPERATING COSTS PER YEAR £10,500

Purchase Outlay

- Car £10,000 – £20,000 based on personal choice
Some instructors use PCP finance or leasing for approx £250 p/month
- Dual controls £450
- Car signage and roof display £0.00 (when driving as a Chris Kelly Instructor)

Income based on £70 per 100minute lesson (The Chris Kelly Lesson Format)

Guide Income **£67,200** based on
4 lessons per day, 5 days per week, 48 weeks per year.

*The pupils are provided via the Chris Kelly headquarters.
There is currently a 3 month waiting list for pupils, making instructor diaries very busy.*

INCOME AFTER OPERATING COSTS (Based on above operating costs) £56,700

INCOME AFTER –

NATIONAL INSURANCE, TAX & PENSION CONTRIBUTIONS OF APPROX £11,000 P/YEAR
= **£45,700** Take Home Pay based on a 48 working week year.

= £3,808 per month (take home pay after ALL COSTS / TAXES etc)

Benefits – Flexibility, earn more than above or work less based on personal preference.

Criteria

Over 21 years old, driving license holder for 3.5years (Hong Kong license counts)
Maximum of 5 penalty points on license, acquire a DBS Certificate.
